The meeting of The District Development Committee in respect of Biswanath District was held under the Chairmanship of The Deputy Commissioner, Biswanath on 10/02/2022 at 11.00 am in Joypur, Gohpur Sub-Division. The meeting was attended by CEO, Zilla Parishad, Biswanath, Addl. Deputy Commissioner, Asstt. Commissioners and all other officials of all the Departments in Biswanath District.

After a threadbare discussion, the following department wise resolutions were taken:

PWD (B)	<ul style="list-style-type: none"> ➤ Asstt.Executive Engineer, PWD(B) is directed to call the concerned contractor of Sakomatha Model School immediately and direct him to complete the balance work within February 2022. ➤ A meeting of the School committee to be convened and steps for cleanliness of the school to be undertaken and to issue instruction to maintain the school properly. ➤ The contractors concerned with the construction of tea garden schools to be called and the pending works to be started immediately. ➤ The AEE is directed to call the contractor of Majuligarh Model Residential school and enquire about the progress of work.

Irrigation	<ul style="list-style-type: none"> ➤ The ongoing schemes under NABARD and SOPD-G to be completed at the earliest. ➤ The 9 (Nine) Nos of pending schemes under PMKSY to be completed within February 2022. ➤ The Executive Engineer (Irrigation) and District Agriculture Officer(DAO) is directed to cause a joint physical verification of the non functional borewell and steps to be taken to make them functional.
6.	Transport	<ul style="list-style-type: none"> ➤ The pending 69 lakhs of target of revenue collection to be completed by 31st March 2022.

Education	<ul style="list-style-type: none"> ➤ DPO, SSA is directed to complete the grouping of schools and appointment of external evaluators for Gunotsav. ➤ BEEO is directed to aware the drop out children belonging to tea garden areas about the 45 days vocational training to be conducted in Jawahar Navodaya Vidyalaya,Biswanath Chariali so that they can avail the benefit of the training. ➤ He is further directed to provide the list of single teachers under SSA to The Deputy Commissioner,Biswanath. ➤ One existing Higher Secondary school in each block of the District to be selected by BEEO and take initiatives to develop the school as a Model School.
8.	Sports	<ul style="list-style-type: none"> ➤ Talent Hunt Competition to be organized by District Sports



9.	Veterinary	<ul style="list-style-type: none"> ➤ Sub-Divisional Veterinary Officer (SDVO) is directed to convene a meeting with all banks regarding KCC. ➤ SDO(C), Gohpur is also directed to convene a meeting with all the banks in Gohpur Sub-Division and resolve issues related to KCC.
10.	Sericulture	<ul style="list-style-type: none"> ➤ The Eri concentration Centre (ECC) at Rangali, Behali Development Block to be developed and fencing to be done.
11.	Handloom and Textiles	<ul style="list-style-type: none"> ➤ Meeting to be convened in March 2022 regarding holding of Exhibition under Handloom cluster Development Programme under SOPD-G scheme
12.	Social Welfare	<ul style="list-style-type: none"> ➤ 2ND Installment to be released to all the Construction Committees of Model Anganwadi Centres.
13.	Employment	<ul style="list-style-type: none"> ➤ The Asst Employment Officer is directed to inform all candidates that the online registration to be done in Public Facilitation Centres(PFCs) in the Offices of Block Development Officer and Municipal Board free of cost.

16.	Industries & Commerce	<ul style="list-style-type: none"> ➤ Convergence Meeting to be convened with banks and other departments like Agriculture,Veterinary,Fishery,Handloom and Textiles.
17.	Zilla Parishad	<ul style="list-style-type: none"> ➤ BDO, Biswanath is directed to identify landless beneficiaries under PMAY. ➤ Circle Officers and CEO,Zilla Parishad is directed to identify land for developing cluster wise housing of landless beneficiaries under PMAY.


