After a threadbare discussion, the following department wise resolutions were taken:-



SL. No.	Department	Resolutions
1.	Handloom & Textile	<ul style="list-style-type: none"> ➤ The Superintendent of Handloom & Textile, Biswanath is instructed to conduct awareness programme to register weavers name in the Flagship scheme “ Swanirbhar Naari” and ensure to procurement Handloom items directly from weavers through the online portal to provide assured income to weavers. ➤ The Deputy Commissioner, Biswanath advised the Superintendent of Handloom & Textile, Biswanath to fixation of rate of various articles collaboration with NRLM (National Rural Livelihood Mission).
2.	A.H. & Veterinary	<ul style="list-style-type: none"> ➤ The Sub-divisional, A.H. & Veterinary Officer, Biswanath is instructed to discuss with bank managers to sanction KCC (KISAN Credit Card) loan to help farmers and increase piggery & poultry farming.
3.	Zilla Parishad	<ul style="list-style-type: none"> ➤ The CEO, Biswanath, Zilla Parishad is instructed to increase progress of cumulative PMAY-G report at the earliest. ➤ The CEO, Biswanath, Zilla Parishad is advised to progress status of schemes related to 15th Finance Commission as soon as possible.
4.	PHE	<ul style="list-style-type: none"> ➤ The Executive Engineer, PHE, Biswanath is directed to complete Retrofitting PWSS of schemes before next DDC. ➤ The Deputy Commissioner Biswanath advised the Executive Engineer, PHE, Biswanath to complete the construction of Soak Pit under ‘Swachh Bharat Mission Grameen’.

5.	Irrigation	<p>➤ Solar Powered MDTW I/S at Behali Block, Solar powered MDTW I/S at Baghmara Block and Solar powered MDTW scheme under SOPD for the year 2018-19 under Biswanath the physical progresses are very slow, 41%, 12% & 27.54% only. So, the Executive Engineer, Irrigation of Biswanath is instructed to call contractors and organize a meeting with the Deputy Commissioner, Biswanath.</p>
6.	Water Resources	<p>➤ Anti erosion measures to protect Botiamari and its adjoining area from the erosion of river Brahmaputra, the physical progress only 25%. So, the Executive Engineer, Water Resources, Tezpur Division is directed to ensure the matter and complete it as soon as possible.</p>
7.	PWD (Territorial Roads)	<p>➤ Status of SOPD (G) 2017-18, 2018-19, 2019-20, 2020-21, overall progress 96.27% . Hence, the Executive Engineer, PWD (TR), Biswanath is instructed to complete it before next DDC.</p> <p>➤ The Executive Engineer, PWD (TR), Biswanath is directed to complete all the schemes for the years 2019-20, 2020-21 at the earliest.</p>
8.	PWD (Building)	<p>➤ The Executive Engineer, PWD (B), Biswanath is instructed to upload current photographs of all schemes in power point presentation in next DDC.</p>
9.	APDCL	<p>➤ The Assistant General Manager, APDCL, Biswanath is directed to complete 100% electrification of Primary Schools & Anganwadi Centres before next DDC.</p>
10.	Fishery	<p>➤ The Fishery Officer, Biswanath is directed to increase fish production and try to make self sufficient in Biswanath District through it.</p>
11.	Health	<p>➤ The Joint Director of Health Services, Biswanath is directed to provide treatment during the period of delivery of women and try to reduce MMR (Maternal Mortality Ratio) in Biswanath.</p>
12.	Agriculture	<p>➤ The District Agriculture Officer, Biswanath is directed to implement agriculture and poultry farm related schemes for reduce unemployment in Biswanath District.</p>
13.	Social Welfare	<p>➤ The I/C District Social Welfare Officer, Biswanath is directed to complete construction of 'One Stop Centre' as soon as possible.</p>
14.	Sericulture	<p>➤ The Superintendent of Sericulture, Biswanath is directed improve 'Sericulture Model Village'. The Deputy Commissioner Biswanath will be visit Sericulture Department for monitoring it.</p>

15.	Education	➤ The DEEO, Biswanath is instructed to discuss with head masters of all schools under Biswanath for implementation of Vidyanjali, the State Government Mission.
16.	Fishery, AH Vety, Agriculture & Dairy	➤ The Hon'ble MLA of Sootea LAC directed the HODs of Fishery, Agriculture, A.H. & Veterinary and Dairy Department to increase production of fish, mutton, chicken, Egg, milk etc. to introduce Biswanath District as self sufficient and help Government to make ' Swanirbhar Assam '

The Chairman asked all concerned HODs to complete the target and sort out inter departmental issues with relevant solutions and bring the notice of the issues which are yet to be resolved.

The meeting ended with the vote of thanks from the chair.


